

Pack Business Flex Multi Line : TEL with Multi Line option + INT (with or without MOB and with or without TV)

Contract summary

This contract summary provides the main elements of this service offer as required by the EU law (1). It helps to make comparison between service offers. Complete information about the service is provided in other documents.

Service and equipment

Pack including Fixed Voice Telephony with Multi Line Option and Fixed Internet Access with or without Mobile Voice Telephony / Mobile Internet Access, with or without TV services.

Fixed Voice Telephony : with Multi Line option :

One IP line

- National calls :
 - Unlimited calls from the fixed line to national fixed lines (voice telephony) 24h/7.
 - 10,000 call minutes for calls from the fixed line (voice telephony) to all mobile numbers in Belgium 24h/7, after these 10,000 call minutes the customer calls at preferential rates.
- International calls:

Once these 1.000 call minutes have been used , the customer will benefit from preferential rates for his calls. All calls not covered by the benefits set out above are billed to the customer at preferential rates.
- The conditions do not apply to special and premium numbers (070, 077, 09xx, 1xxx, etc.).
- First 2 licences (for 2 users with one fixed number each)
- Additional licence with a fixed number available as an option
