

## JOINT OFFERS – MOBILE

### Contract summary

This contract summary provides the main elements of this service offer as required by EU law <sup>(1)</sup>. It helps to make comparison between service offers. Complete information about the service is provided in other documents.

### Services and equipment

#### Mobile Voice Telephony and Mobile Internet Access

In addition to the mobile service subscription which remains unchanged, the optional joint offer includes:

- **an equipment:** a smartphone of your choice out of the different models that are available in a joint offer
- **a mandatory option** of your choice (according to the compatibility with the mobile subscription and the smartphone model) amongst:
  - Special Deal : discount on the one-shot fee on the purchase price of the smartphone
  - Data Phone : additional mobile data volume (Belgium and EU)
- **An amortization table** reflecting the remaining value of the equipment until the end of the contract is added to the contract

### Price

- **The monthly fee of the mobile service** subscribed previously remains unchanged
- **One shot fee for the acquisition of the equipment:** payable upon the conclusion of the contract, variable in function of the smartphone model and in function of the mandatory option (Special Deal or DataPhone) (see [Mobile subscriptions with a smartphone | Proximus](#))
- **Monthly subscription to the mandatory option** (prices in €, VAT excluded) according to the compatibility with the mobile subscription and the smartphone model.

    - DataPhone 1 GB at € 8,26/ month
    - DataPhone 1,5 GB at € 12,40/ month
    - DataPhone 2 GB at € 16,53/ month

    - DataPhone 3,5 GB at € 28,93/ month

- Undefined term concerning the service fee
