## **Contract summary**

This contract summary provides the main elements of this service offer as required by the EU law (¹). It helps to make comparison between service offers. Complete information about the service is provided in other documents.

## Services and equipment

Pack with Fixed Voice, Fixed Internet Access and TV services, with or without Mobile Voice Telephony/Mobile Internet Access.

Fixed Voice: Unlimited calls national:

- Unlimited calls from the landline to national landlines (voice access line) 24h/7.
- 1.000 call minutes for landline calls (voice access line) to all mobile numbers in Belgium during peak and off-peak hours; after these 1,000 call minutes the customer calls at preferential rates. NB: these conditions do not apply to special numbers (070, 077, 09xx, 1xxx etc.).

- Emergency Internet: your plan B in case of an interruption of your internet (only when mobile in pack)

- My e-Press: Unlimited access to Le Soir+ or Het Laatste Nieuws Digitaal
- Family life Premium app: simplify your daily life
