# Mobile Voice Telephony Service

The Pay&Go+ prepaid offer includes a € 10 call credit and is valid in Belgium and while roaming in the European Union after using any bonuses.

Bonuses are awarded upon card activation and for each top-up of more than  $\leq$  10. The bonus content varies according to the top-up amount and the top-up method used. They are valid for 31 days from card or top-up activation date.
