BUSINESS TRUNKING

Contract summary

Service

Fix voice telephony

Business Trunking is a fixed VoIP telephony service that provides the Customer with fixed numbers, voice channels and access to public telephone services. With the Service, the Customer can make calls to the Proximus public telephone network and to other fixed and mobile networks connected to it.

Pre-requisites

Except for the **Cloud Advanced** flavour of the service, the CPE and the PBX/SBC, which are compatible with the Service and although necessary for the use of the Service, are not included in the Service.

- Monthly subscription for a 12-month contract and up to 20 channels (in €, per month, excl. VAT)

- Service charges due until the service is deactivated. In case of early termination during the initial term, the termination indemnity indicated in the contract is due.
